WHO: Plainfield residents who have completed kindergarten thru 8th grade
For children who have completed Pre-K a summer program is available through the Recreation PreK program

WHAT: Daily sports, games, crafts, weekly themes & weekly special events
TEENS! For students in 6th, 7th & 8th grade special weekly trips are offered.

FEES: **\$350 for whole program** (limited Financial aid available)

TIME: 9:00am- 3:00pm

IMPORTANT: **AM Busing Only -cluster neighborhood pick-ups will be available**

EXTENDED DAY PROGRAM:

For an additional fee an **extended program** is available for late parent pick-up and early drop-off from 6:30-9:00am & 3:00pm-6:00pm. Fee is for all six weeks. This program is billed in two installments. You must register for this program in advance and pay first Installment with first program payment.

6:30-9:00AM	\$180 (\$90 1st installment due by May 5th balance \$90 due June 2nd)
3:00-6:00PM	\$180 (\$90 1st installment due by May 5th balance \$90 due June 2nd)

HOW TO REGISTER: REGISTRATION INFORMATION

- ◆ Registration is on a first come, first served - basis. Space is limited per grade level
- ◆ Register early for the best payment plan.
- ◆ DO NOT RETURN FORM TO SCHOOLS
- ◆ A parent or legal guardian must complete a registration form and return it to the Recreation Office.
- ◆ Last day to register is when program is full or June 2nd which ever comes first.
- ◆ **A child is registered when a completed registration form and non-refundable \$50 deposit per child is received in the Recreation Office. Deposit is deducted from final payment.**
1/2 payment is due by May 5th and final payment due by June 2nd
- ◆ NO REFUNDS AFTER JUNE 2nd
- ◆ No child will go on the roster or bus route without final payment by June 2nd.
- ◆ A WEEK PRIOR TO THE START OF PROGRAM A PARENTS PACKET WILL BE MAILED WITH A CALENDAR OF ACTIVITIES AND OTHER IMPORTANT INFORMATION

All fees and programs are pending approval of annual Town Budget.



I agree for myself, my family, heirs, executors and administrators to not sue and to release, indemnify and hold harmless the Town of Plainfield and their affiliates, officers, directors, employees, volunteers, successors and assigns from any and all liability, claims, demands and causes of action whatsoever, that may arise from the participation of myself or my minor child in town sponsored activities and its various programs on or off-site, whether it results from the negligence of any of the above named persons or entities or from any other cause. This release and indemnification agreement shall be as broad and inclusive as is permitted by the law of the State of Connecticut. If any portion of it is held invalid, the balance shall continue in full force and effect. **PHOTO RELEASE:** I understand that for promotional purposes, the Town of Plainfield and local media takes photographs of participants enrolled in recreational activities, classes or programs.
