## **SUMMER TEEN PROGRAM**

This is a daily outdoor program that has so much to offer Plainfield “Teens” such as sports, games crafts and **weekly trips**. It is a great social program and time for students to be with peers. They can choose self directed daily activities with supervision. Students must meet attendance and community service requirements to go on trips.

**Where do we go?** Some of the places we have visited are: Adventure Park, Brownstone, ball games, Lake Compounce, ocean kayaking, Rocky Neck. This year’s trips are still being planned. Many trips are based on ideas from last years participants.

**WHO:** Plainfield residents who have completed 6th thru 8th grade  
**DATES:** Wednesday June 28th thru Wednesday August 9th 6 weeks (no program Monday July 4th)  
**WHERE:** Shepard Hill Elementary School  
**FEES:** **\$350 for whole 6 week program (fees off set trips and transportation)**  
Plus small weekly fees for trips that you choose to go on  
**TIMES:** 9:00am- 3:00pm  
**EXTRA:** AM Busing- Cluster /neighborhood busing is available. NO PM bus  
**EXTENDED DAY:** Available from 6:30am-9:00am and or 3:00pm-6:00pm for an additional fee.

## **REGISTRATION INFORMATION**

- ◆ Registration is on a first come, first served - basis. Space is limited. DO NOT RETURN FORM TO SCHOOLS
- ◆ A parent or legal guardian must complete a registration form and return it to the Recreation Office.
- ◆ Last day to register is when program is full or June 5th which ever comes first.
- ◆ **A child is registered when a completed registration form and non-refundable \$50 deposit per child is received in the Recreation Office. Payment plans and limited financial aid is available.**  
**Deposit is deducted from final payment.**  
**1/2 payment is due by May 5th and final payment due by June 2nd**
- ◆ NO REFUNDS AFTER JUNE 2nd
- ◆ No child will go on the roster without final payment by June 2nd
- ◆ A WEEK PRIOR TO THE START OF PROGRAM A PARENTS PACKET WILL BE MAILED WITH A CALENDAR OF ACTIVITIES, BUSING AND OTHER IMPORTANT INFORMATION

This release and indemnification agreement shall be as broad and inclusive as is permitted by the law of the State of Connecticut.
